1 3. I make this declaration in support of the *Motion for Turnover of Bankruptcy Estate*
2 *Property Pursuant to 11 U.S.C. § 542(e)* (the “Motion”).²

3 4. On March 19, 2026 an involuntary Chapter 7 petition was filed against Cartwheel
4 Robotics, Inc. (the “Debtor”). [ECF No. 1].³

5 5. On April 14, 2026, this Court entered an Order for Relief. [ECF No. 7].

6 6. I was thereafter appointed as the Chapter 7 Trustee pursuant to 11 U.S.C. § 701.

7 7. Respondent is the Debtor’s president and, upon information and belief, has
8 possession, custody, and/or control of the Debtor’s financial records, books, and recorded
9 information relating to the Debtor’s property and financial affairs, including the Information.

10 8. I requires the Information requested to perform my statutory duties under 11
11 U.S.C. § 704, including identifying estate assets, investigating financial affairs, and evaluating
12 potential avoidance actions.

13 9. I therefore seek turnover of the Information from the Respondent.

14 I declare under penalty of perjury under the laws of the United States that the foregoing is
15 true and correct.
