19 The Court, having considered the *Ex Parte Application for Order Shortening Time On*  
20 *Motion for Turnover of Bankruptcy Estate Property Pursuant to 11 U.S.C. § 542(a)* (“OST  
21 Motion”), filed by Trustee Bradley G. Sims (“Trustee”), seeking an order shortening time  
22 for the hearing on his *Motion for Turnover of Bankruptcy Estate Property Pursuant to 11 U.S.C.*  
23 *§ 542(e)*; and having found cause is present to hear the Motion on shortened time:

24 **NOTICE IS HEREBY GIVEN** that the *Motion for Turnover of Bankruptcy Estate*

1 *Property Pursuant to 11 U.S.C. § 542(a)* (the “Motion”) was filed by the Trustee in the above-  
2 captioned bankruptcy case.

3 The Motion seeks an order compelling Scott LaValley, (the “Respondent”), as president of  
4 the Debtor, to turn over all property of the Debtor in his possession, including but not limited to  
5 tangible assets, vehicles, hardware, software, intellectual property, source code, repositories,  
6 robotics systems, prototypes, models, YOGI, Speedy, and all associated hardware, firmware,  
7 design files, engineering documentation, and component parts related thereto (the “Property”).

8 A copy of the Motion, and the *Declaration of Bradley G. Sims in Support of Motion for*  
9 *Turnover of Bankruptcy Estate Property Pursuant to 11 U.S.C. § 542(a)* are on file with the  
10 Clerk’s Office of the United States Bankruptcy Court, 300 Booth Street, Reno, Nevada 89509.  
11 Copies of the Motion and any supporting declarations may also be obtained from counsel for the  
12 Trustee or through the Bankruptcy Court’s website at [www.nvb.uscourts.gov](http://www.nvb.uscourts.gov).

13 **NOTICE IS FURTHER GIVEN** that if you do not want the Court to grant the relief  
14 sought in the Motion, or if you want the Court to consider your reviews on the Motion, then you  
15 must file an opposition with the Court, and serve a copy of the person making the Motion ***no later***  
16 ***than April 22, 2026***. The opposition must state your position, set forth all relevant facts and legal  
17 authority, and be supported by affidavits or declarations that conform to Local Rule 9014(c).

18 If you object to the relief requested, you *must* file a **WRITTEN** response to this pleading  
19 with the court. You *must* also serve your written response on the person who sent you this  
20 notice.

21 If you do not file a written response with the court, or if you do not serve your written  
22 response on the person who sent you this notice, then:

- 23 • The Court may *refuse to allow you to speak* at the scheduled hearing; and
- 24 • The Court may *rule against you* without formally calling the matter at the hearing.

26 **NOTICE IS FURTHER GIVEN** that absent further order of the Court, a hearing on said  
27 Motion shall be heard by a United States Bankruptcy Judge on the 24<sup>th</sup> day of April, 2026 at  
28 10:30 a.m. prevailing Pacific Time. Parties are permitted to appear telephonically by dialing (833)

1 435-1820 and entering Meeting ID (if applicable) 160 532 0260, and entering Participant Code:  
2 643758#. Parties wishing to appear in person at the courthouse may do so. If you intend to  
3 participate at this hearing please check the Court’s website prior to the hearing for any updated  
4 instructions relating to whether the hearing is in person or conducted remotely including the  
5 applicable Court participation number and access code. You may view the Court Calendar at:

8 **NOTICE IS FURTHER GIVEN** that this hearing may be continued from time to time

10 above-noted hearing or any adjournment thereof.
