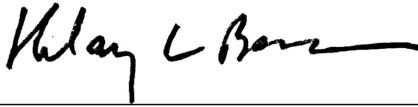

¹ Unless otherwise indicated, all chapter and section references are to the Bankruptcy Code, 11 U.S.C. §§ 101-1532, and to the Federal Rules of Bankruptcy Procedure, Rules 1001-9037. The Federal Rules of Civil Procedure will be referred to as “FRCP” and the Federal Rules of Bankruptcy Procedure will be referred to as “FRBP.” The Local Rules of Practice for the United States Bankruptcy Court for the District of Nevada shall be referred to as the “Local Rules”.

1 This matter was considered by the Court on the *Motion for Turnover of Bankruptcy Estate*
2 *Property Pursuant to 11 U.S.C. § 542(e)* (the “Motion”) [ECF No. 13], filed by Bradley G. Sims
3 (the “Trustee”), the duly appointed Chapter 7 Trustee in the above-captioned bankruptcy case.
4 The Motion sought an order compelling Scott LaValley, (the “Respondent”) to turn over and
5 account for all recorded information of the Debtor, including electronically stored information,
6 cloud-based records, and data maintained on third-party platforms, in his custody or control to the
7 Trustee, including but not limited to, the Debtor’s bank statements, other financial statements,
8 general ledgers, balance sheets, records of accounts receivable, records of accounts payable,
9 accounting records, tax returns and filings, corporate governance documents, cap table and
10 investor records, all contracts, non-disclosure agreements, employment and contractor
11 agreements, intellectual property assignment agreements, payroll records, records of all transfers
12 of funds, including transfers during the period from the petition date through the Order for Relief,
13 documentation of any loans, liens, or encumbrances, records of any transfer of intellectual
14 property, and access credentials and information necessary to obtain such records from third
15 parties (collectively the “Recorded Information”).²

16 The Court reviewed the Motion, the *Declaration of Bradley G. Sims in Support of Motion*
17 *for Turnover of Bankruptcy Estate Property Pursuant to 11 U.S.C. § 542(e)* [ECF No. 14], the *Ex*
18 *Parte Application for Order Shortening Time on Motion for Turnover of Bankruptcy Estate*
19 *Property Pursuant to 11 U.S.C. § 542(e)* [ECF No. 15]; the *Declaration of Bradley G. Sims In*
20 *Support of Ex Parte Application for Order Shortening Time on Motion for Turnover of*
21 *Bankruptcy Estate Property Pursuant to 11 U.S.C. § 542(e)* [ECF No. 16]; the *Attorney*
22 *Information Sheet in Support of Motion for Turnover of Bankruptcy Estate Property Pursuant to*
23 *11 U.S.C. § 542(e)* [ECF No. 17], the *Notice of Hearing and Order Shortening Time for Hearing*
24 *on Motion for Turnover of Bankruptcy Estate Property Pursuant to 11 U.S.C. § 542(e)* [ECF No.
25 25], the *Response and Limited Opposition of Scott LaValley to Trustee’s Motion for Turnover*
26 *Pursuant to 11 U.S.C. § 542(e) and (a)* [ECF No. 30]; the *Motion to Continue Hearing on*

8 appearances were noted on the record.

9 Based upon consideration of the pleadings and good cause appearing,

10 **IT IS HEREBY ORDERED** that:

- 11 1. The Motion is GRANTED in its entirety; and
- 12 2. The Respondent shall turn over the Recorded Information in his possession,
13 custody or control to the Trustee within seven (7) days of the entry of this order; and
- 14 3. To the extent any Recorded Information of the Debtor is not in Respondent's
15 possession, custody, or control, Respondent shall, within seven (7) days of entry of this Order,
16 provide a written accounting under penalty of perjury that:
 - 17 (a) identifies each such item Recorded Information;
 - 18 (b) identifies the current location of such Recorded Information;
 - 19 (c) identifies all persons or entities having possession, custody, or control thereof;
 - 20 (d) describes any transfer of such Recorded Information, including the date,
21 manner of transfer, consideration received, and identity of the transferee; and
 - 22 (e) identifies all documents supporting the foregoing.

23 **IT IS SO ORDERED.**
