

¹ Unless otherwise indicated, all chapter and section references are to the Bankruptcy Code, 11 U.S.C. §§ 101-1532, and to the Federal Rules of Bankruptcy Procedure, Rules 1001-9037. The Federal Rules of Civil Procedure will be referred to as “FRCP” and the Federal Rules of Bankruptcy Procedure will be referred to as “FRBP.” The Local Rules of Practice for the United States Bankruptcy Court for the District of Nevada shall be referred to as the “Local Rules”.

1 This matter was considered by the Court on the *Motion for Turnover of Bankruptcy Estate*
2 *Property Pursuant to 11 U.S.C. § 542(a)* (the “Motion”) [ECF No. 18], filed by Bradley G. Sims
3 (the “Trustee”), the duly appointed Chapter 7 Trustee in the above-captioned bankruptcy case.
4 The Motion sought an order compelling Scott LaValley, (the “Respondent”) to turn over and
5 account for all property of the Debtor in his possession, custody, or control, including but not
6 limited to tangible assets, vehicles, hardware, software, intellectual property, source code,
7 repositories, robotics systems, prototypes, models, YOGI, Speedy, and all associated hardware,
8 firmware, design files, engineering documentation, and component parts related thereto (the
9 “Property”).²

10 The Court reviewed the Motion, the *Declaration of Bradley G. Sims in Support of Motion*
11 *for Turnover of Bankruptcy Estate Property Pursuant to 11 U.S.C. § 542(e)* [ECF No. 19], the *Ex*
12 *Parte Application for Order Shortening Time on Motion for Turnover of Bankruptcy Estate*
13 *Property Pursuant to 11 U.S.C. § 542(a)* [ECF No. 20]; the *Declaration of Bradley G. Sims In*
14 *Support of Ex Parte Application for Order Shortening Time on Motion for Turnover of*
15 *Bankruptcy Estate Property Pursuant to 11 U.S.C. § 542(a)* [ECF No. 21]; the *Attorney*
16 *Information Sheet in Support of Motion for Turnover of Bankruptcy Estate Property Pursuant to*
17 *11 U.S.C. § 542(a)* [ECF No. 22], the *Notice of Hearing and Order Shortening Time for Hearing*
18 *on Motion for Turnover of Bankruptcy Estate Property Pursuant to 11 U.S.C. § 542(a)* [ECF No.
19 26], the *Response and Limited Opposition of Scott LaValley to Trustee’s Motion for Turnover*

26 No. 33]; the *Trustee’s Opposition to Motion to Continue Hearing on Trustee’s Motion for*

1 *Turnover* [ECF No. 34]; the exhibits attached thereto, and all the pleadings on file herein. All
2 appearances were noted on the record.

3 Based upon consideration of the pleadings and good cause appearing,

4 **IT IS HEREBY ORDERED** that:

5 1. The Motion is GRANTED in its entirety; and

6 2. The Respondent shall turn over the Property in his possession, custody or control
7 to the Trustee within seven (7) days of the entry of this order; and

8 3. Respondent shall provide the Trustee with immediate access to all locations where
9 the Property in his possession, custody or control is stored and shall cooperate in facilitating
10 retrieval of such Property; and

11 4. To the extent any of the Property of the Debtor is not in Respondent's possession,
12 custody, or control, Respondent shall, within seven (7) days of entry of this Order, provide a
13 written accounting under penalty of perjury that:

14 (a) identifies each such item of the Property;

15 (b) identifies the current location of such Property;

16 (c) identifies all persons or entities having possession, custody, or control thereof;

17 (d) describes any transfer of such Property, including the date, manner of transfer,
18 consideration received, and identity of the transferee; and

19 (e) identifies all documents supporting the foregoing.

20 **IT IS SO ORDERED.**
