21 **NOTICE IS HEREBY GIVEN** that the *Motion for an Order (i) Designating Scott*
22 *LaValley as Person Required to Perform the Duties of the Debtor Pursuant to FRBP 9001(b)(5),*
23 *and (ii) Compelling Filing of Schedules, Statements, and Appearance at § 341 Meeting* (the
24 *“Motion”*) was filed by Bradley G. Sims (the *“Trustee”*), the Chapter 7 Trustee in the above-

2 The Motion seeks entry of an order pursuant to FRBP 9001(b)(5) designating the Debtor's
3 president, Scott LaValley (the "Respondent"), as the person required to perform the duties of the
4 Debtor, and compelling Respondent to (i) file the Debtor's schedules and statements, (ii) provide
5 required information to the Trustee, and (iii) appear and testify at the meeting of creditors.

6 A copy of the Motion and the *Declaration of Bradley G. Sims in Support of Motion for an*
7 *Order (i) Designating Scott LaValley as Person Required to Perform the Duties of the Debtor*

16 ***later than fourteen days before the hearing date.*** The opposition must state your position, set
17 forth all relevant facts and legal authority, and be supported by affidavits or declarations that
18 conform to Local Rule 9014(c).

19 If you object to the relief requested, you *must* file a **WRITTEN** response to this pleading
20 with the court. You *must* also serve your written response on the person who sent you this
21 notice.

22 If you do not file a written response with the court, or if you do not serve your written
23 response on the person who sent you this notice, then:
