18 RSF Robotics I, a series of RSF Master LLC, the Wong Family Revocable Trust, and Nevada
19 Battle Born Growth Escalator, Inc. (collectively, the “Petitioning Creditors”), by and through their
20 undersigned counsel, hereby submit this Joinder and Response to the *Motion for Order (I)*
21 *Designating Scott LaValley as Person Required to Perform the Duties of the Debtor Pursuant to*
22 *FRBP 9001(b)(5), and (II) Compelling Filing of Schedules, Statements, and Appearance at § 341*
23 *Meeting* [ECF No. 41] (“Motion”). Petitioning Creditors join in the Trustee’s Motion and file this
24 response to discuss Scott LaValley’s (“Scott”) testimony at Cartwheel Robotics Inc.’s (“Debtor”)
25 Section 341 meeting of creditors held on May 21, 2026 (“Section 341 Meeting”). Petitioning
26 Creditors further assert that in addition to Scott, the Court should consider designating Samantha
27 Conway and Bill LaValley as persons required to perform the duties of the Debtor under FED. R.
28

1 BANKR. P. 9001(b)(5).¹

2 During the Section 341 Meeting, Scott consistently feigned a lack of knowledge² regarding
3 Debtor's operations (information which a Chief Executive Officer would be required to know to
4 satisfy his fiduciary duty),³ instead claiming Samantha Conway (whom he testified was Debtor's
5 Chief Operating Officer) may have that information. Indeed, the Nevada Secretary of State's
6 website identified Samantha Conway as Debtor's secretary and treasurer until that information was
7 updated on January 19, 2026, to reflect Scott as occupying those positions (curiously, after the date
8 of Scott's departure from Debtor based on his testimony at the Second 341 Meeting). *See Exhibit*
9 **2.**⁴ The Nevada Secretary of State's website further identifies Samantha Conway as the secretary of
10 Autonomous Ops, Inc. (*see Exhibit 3*) and the registered agent and a manager (until, curiously, an
11 amended list was filed on May 15, 2026, purportedly excluding her as a manager) of 6127 Reno
12 Hwy, Inc. (*see Exhibit 4*).

13 During the Section 341 Meeting, Scott further testified that he left all assets, books, and
14 records in the Debtor's leased premises and turned over the keys to the landlord (which he also
15 testified was his father) by leaving them in the leased premises. *See also Motion of Secured Creditor*

18 ¹ The Petitioning Creditors believe the Court has the absolute right under FED. R. BANKR. P.
19 9001(b)(5) to appoint Samantha Conway because she is an officer and Bill LaValley because he
20 is a person in control, without the necessity of a separate motion and without further notice.

21 ² Such lack of knowledge included basic information such as (i) the identity of the landlord for
22 Debtor's leased premises (i.e., 6127 Reno Hwy, LLC or Autonomous Ops, Inc.), (ii) the
23 management of the landlord (even though he testified that his father was involved with the
24 landlord), (iii) the current location of business records, and (iv) the name of the appraiser who
25 allegedly appraised the Debtor and its assets months prior to the petition date. Despite claiming
26 to lack this basic information (and, according to his response to the Motion, lacking time to
27 participate in this case), Scott nevertheless presents himself as a knowledgeable businessman, and
28 he has found the time to create a website tracking this case for the benefit of the general public
(and presumably future startup companies). *See Exhibit 1*.

³ The Petitioning Creditors believe that Scott's testimony at the Section 341 Meeting reflects he
failed to abide by his fiduciary duties, thereby potentially subjecting him to liability (either
personally or under the alleged D&O policy Scott testified the Debtor may have had but for which
Samantha Conway would likely have more information).

⁴ Petitioning Creditors respectfully request the Court to take judicial notice of the exhibits attached
hereto pursuant to FED. R. EVID. 201.

1 *Scott LaValley for Production of Documents Pursuant to Federal Rule of Bankruptcy Procedure*
 2 *2004*, ECF No. 63, p. 26 of 30 (in a January 14, 2026, email, Scott LaValley wrote “as you know,
 3 the landlord is a family member.”). And despite testifying that he voluntarily left keys in the leased
 4 premises without taking any of the Debtor’s books and records or other assets with him, a December
 5 24, 2025, email from Scott LaValley contradicts this by asserting that the landlord (i.e., his father)
 6 “controls the company’s assets through a lease default that resulted in lockout....” *Id.* at p. 21 of 30.

7 Notwithstanding these inconsistencies, Scott’s testimony at the Section 341 Meeting and his
 8 emails he voluntarily filed, reflect that the landlord (i.e., his father, who is a manager of 6127 Reno
 9 Hwy, LLC and the president of Autonomous Ops, Inc.) was provided a security interest in Debtor’s
 10 assets “for one year of unpaid rent, secured by all assets, both tangible and intangible....” *Id.* And
 11 that retroactive security interest was not perfected until October 21, 2025, by 6127 Reno Hwy, LLC
 12 (presumably the landlord, i.e., his father), right around the same time Scott testified at the Section
 13 341 Meeting the Debtor was experiencing financial difficulties. *See Exhibit 5.* Coincidentally (and
 14 questionably), Scott and Samantha Conway also recorded security interests on October 21, 2025, for
 15 monies Scott testified were allegedly loaned to fund payroll (and approved by Scott as the Board of
 16 Directors because, in his testimony at the Section 341 Meeting, he was the Board of Directors at that
 17 time). *See id.*

18 FED. R. BANKR. P. 9001(b)(5)—the statutory provision on which the Trustee’s Motion is
 19 based—states, in pertinent part:

20 (5) “Debtor,” when the debtor is not a natural person and either is required
 21 by these rules to perform an act or must appear for examination, includes:

22 (A) if the debtor is a corporation and if the court so designates:

- 23 • **any or all** of its officers, directors, trustees, or members of a
 similar controlling body;
- 24 • a controlling stockholder or member; or
- 25 • any other person in control....

26 (Emphasis added.) Bankruptcy Rule 9001(b)(5) therefore recognizes that more than one person may
 27 be designated as a person required to perform the duties of the Debtor. Here, Petitioning Creditors
 28 respectfully submit that both Samantha Conway and Bill LaValley, along with Scott, should all be
 designated as persons required to perform the duties of the Debtor.

1 Regarding Samantha Conway, she was the Debtor’s Chief Operating Officer, Secretary, and
2 Treasurer.

3 Regarding Bill LaValley, he is an insider of the Debtor who, according to Scott’s testimony
4 at the Section 341 Meeting, potentially has control and/or possession of all of Debtor’s assets⁵ and
5 books and records based on a security interest provided (preferentially) to collateralize one-year of
6 unpaid rent. *See* 11 U.S.C. § 101(31)(B)(vi) (defining an insider regarding a debtor-corporation as
7 including a “relative of a general partner, director, officer, or person in control of the debtor....”).

8 For the reasons set forth herein, the Petitioning Creditors join in the Trustee’s Motion and
9 further respectfully submit that Samantha Conway and Bill LaValley should also be added (in
10 addition to Scott) as designated persons required to perform the duties of the Debtor under FED.
11 R. BANKR. P. 9001(b)(5).

27 than his father’s security interest (the amount of which he could not recall) because the assets were
28 identified as being not as valuable absent manpower (though they were apparently powerful
enough, standing alone, for Scott to attempt to sell to third parties and thereafter allegedly
encumber as collateral for unpaid rent to his father).

I launched a public docket archive for the Cartwheel Robotics bankruptcy case:

This is not the ending I wanted for Cartwheel.

We built a small humanoid robot company around a simple belief: humanoids should not just be capable — they should be trustworthy, expressive, useful, and something people actually want in their lives.

Cartwheel did not voluntarily file for bankruptcy; it is now in an involuntary Chapter 7 proceeding initiated by three petitioning creditors. The public record can be difficult to follow through the court docket alone, so I created this site to make selected filings easier to access and understand.

These filings are not the whole story. They are the opening public record in a case that will continue to develop through the court process over many months.

Some filings include allegations, disputed characterizations, and procedural positions by parties in interest. The archive is not the final word — it is the public record to date.

I had hoped this chapter was behind me and that I could begin moving forward. For now, I am focused on getting through the process.

There is also a hard founder lesson here:

A convertible note is debt.

It may convert into equity later. It may feel like startup financing. It may be described as bridge capital. But until it converts, it is a creditor instrument.

And depending on the terms, it can also create significant control leverage.

Protective provisions, consent rights, board rights, veto rights, default leverage, and investor approval rights can fundamentally change who controls the company — especially when the company becomes distressed or needs more capital.

For founders building startups and seeking outside capital, the financing instrument matters.

Debt versus equity matters.

Governance rights matter.

Control rights matter.

Investor alignment matters.

Counsel alignment matters.

Even changing "and" to "or" can have enormous consequences.

A SAFE is not perfect, but founders should understand the difference between selling future equity and taking on debt that may carry creditor rights and control leverage.

I am sharing the public record because I believe founders should understand these risks before they are living inside them.
