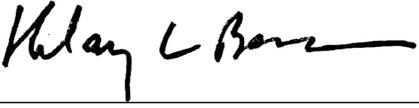

1 employ Houmand Law Firm, Ltd. as his general bankruptcy counsel effective as April 30, 2026,
2 the date of the filing of the Application; and

3 3. The terms of such employment shall be as described in the Application and in the
4 supporting Verified Statement of Jacob L. Houmand, Esq.; and

5 4. Any compensation and reimbursement of expenses are to be awarded by Court
6 order and are to be paid as an administrative expense after notice and a hearing, in accordance
7 with 11 U.S.C. §§ 330 and 503, or surcharged against secured property in accordance with 11
8 U.S.C. § 506(c), if appropriate; and

9 5. The hearing on the Application scheduled for June 11, 2026, at 11:00 a.m. shall be
10 vacated.
