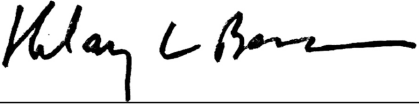

1 This matter came before the Court on the *Motion for Order (I) Designating Scott LaValley*
2 *As Person Required to Perform the Duties of the Debtor Pursuant to FRBP 9001(b)(5), and (II)*
3 *Compelling Filing of Schedules, Statements, and Appearance At § 341 Meeting* [ECF No. 41] (the
4 “Motion”) filed by Bradley G. Sims (the “Trustee”), the Chapter 7 Trustee appointed in the
5 above-captioned bankruptcy case, by and through his counsel of record, Jacob L. Houmand, Esq.
6 of the Houmand Law Firm, Ltd. The Motion sought an order designating Scott LaValley (“Mr.
7 LaValley”) as a person required to perform the duties of the Debtor pursuant to Federal Rule of
8 Bankruptcy Procedure 9001(b)(5), and compelling the filing of schedules, statements, a creditor
9 mailing matrix, and appearance at any continued meeting of creditors.¹

10 Jacob L. Houmand, Esq. appeared on behalf of the Trustee and all other appearances were
11 noted on the record.

12 The Court reviewed the Motion, the *Declaration of Bradley G. Sims In Support of Motion*
13 *for Order (I) Designating Scott LaValley As Person Required to Perform the Duties of the Debtor*
14 *Pursuant to FRBP 9001(b)(5), and (II) Compelling Filing of Schedules, Statements, and*
15 *Appearance At § 341 Meeting* [ECF No. 42], the *Notice of Hearing On Motion for Order (I)*
16 *Designating Scott LaValley As Person Required to Perform the Duties of the Debtor Pursuant to*
17 *FRBP 9001(b)(5), and (II) Compelling Filing of Schedules, Statements, and Appearance At § 341*
18 *Meeting* [ECF No. 43], the *Certificate of Service of Motion for Order (I) Designating Scott*
19 *LaValley As Person Required to Perform the Duties of the Debtor Pursuant to FRBP 9001(b)(5),*
20 *and (II) Compelling Filing of Schedules, Statements, and Appearance At § 341 Meeting* [ECF No.
21 47], the *Opposition of Scott LaValley to Trustee’s Motion for Order (I) Designating Scott*
22 *LaValley As Person Required to Perform the Duties of the Debtor Pursuant to FRBP 9001(b)(5),*
23 *and (II) Compelling Filing of Schedules, Statements, and Appearance At § 341 Meeting* [ECF No.
24 65], the *Petitioning Creditors’ Joinder and Response to Motion for Order (I) Designating Scott*

68], the *Limited Supplemental Response of Scott LaValley, Individually and As Creditor/Party In Interest, to Petitioning Creditors' Joinder and Response* [ECF No. 69], the *Reply In Support of Motion for Order (I) Designating Scott LaValley As Person Required to Perform the Duties of the Debtor Pursuant to FRBP 9001(b)(5), and (II) Compelling Filing of Schedules, Statements, and Appearance At § 341 Meeting* [ECF No. 70], the *Limited Response and Opposition of Samantha Conway to Joinder* [ECF No. 71], the exhibits attached thereto, and all the pleadings on file herein.

Based upon the pleadings and arguments of counsel and the findings of fact and conclusions of law placed on the record at the hearing and incorporated herein pursuant to Federal Rule of Civil Procedure 52, incorporated by reference by Federal Rules of Bankruptcy Procedure 7052, and good cause appearing,

IT IS HEREBY ORDERED that:

1. The Motion is GRANTED as set forth herein; and
2. Mr. LaValley and Samantha Conway ("Ms. Conway") are designated as persons required to act on behalf of the Debtor pursuant to Federal Rule of Bankruptcy Procedure 9001(b)(5); and
3. No later than fourteen (14) calendar days after entry of this Order, Mr. LaValley and Ms. Conway shall prepare and file bankruptcy schedules, statement of financial affairs, and a creditor mailing matrix with this Court; and
